Re: Form of Recall Petition for Trustee Cody Rex Walker

Dear Ms. Schaffer, Ms. Schneider and Mr. Baird,

On February 14, 2019, Mr. Kevin Conrad personally filed with the Town Clerk a revised Recall Petition to recall Trustee Cody Rex Walker. Pursuant to Colorado Revised Statute (CRS) Section 31-4-502(c), as Town Clerk for the Town of Estes Park, I have reviewed the first printer's proof of the petition submitted and have determined the petition meets the requirements. See the attached certification.

Pursuant to Section 31-4-502(d) CRS, you may proceed with collecting signatures from registered electors within town limits equal to 25% of the votes cast for Trustee in the 2018 election. A total of 5,395 votes were casted for three positions on the Board; thus requiring 450 signatures to be collected and certified. Section 31-4-503(2)(a) states the Recall Petition shall be filed with the Town Clerk within sixty (60) days from the date of this letter.

Please note all petition sections submitted to the Town Clerk must contained a notarized affidavit affixed in a manner ensuring the two documents have not been disassembled during or after circulation. The proof demonstrated the document would be bound with cardstock attached to the back of the petition sections and stapled in two locations along the top of the document. Also note the page numbering of the petition needs to be updated as indicated on the attachment to the certification.
