All fines assessed may be increased or decreased if there are mitigating or aggravating factors at the time of sentencing.

ALL VIOLATIONS/ORDINANCES NOT LISTED REQUIRE A MANDATORY COURT APPEARANCE AND ARE SUBJECT TO FINES UP TO \$2,650.00 PURSUANT TO ESTES PARK MUNICIPAL CODE SECTION 1.20

TRAFFIC VIOLATIONS (2, 3 & 4 POINTS)

(On all traffic violations, add an additional \$5.00 per point for an accident and/or each subsequent violation within the past 24 months)

3RD Violation in 24 months – Mandatory Court Appearance

1st VIOLATION within two years.....\$30.00 per point
 2nd VIOLATION WITHIN two years.....\$35.00 per point
 All zero and one point violations.....\$60.00

SPEEDING IN A CONSTRUCTION OR SCHOOL ZONE
 FINES WILL BE DOUBLED BASED ON ORIGINAL CHARGE

*** ANY TRAFFIC VIOLATION 6 OR MORE POINTS, TRAFFIC ACCIDENTS WITH A CHARGE 4 POINTS OR OVER, MINORS and CDL HOLDERS – MANDATORY COURT APPEARANCE***
