Minutes of a regular meeting of the Board of Trustees of the Town of Estes Park, Larimer County, Colorado. Meeting held in the Town Hall in said Town of Estes Park on the 27th day of November, A. D. 1933, at regular meeting hour.

Meeting called to order by Mayor Frank C. Bond

Present: Mayor Frank C. Bond Trustees: C. Byron Hall, T. C. Jelsema, Clyde M. Low, Glen H. Preston, E. R. Rivers, and C. N. Rockwell. Clerk, Chas. F. Hix. Absent, none.

Minutes of a regular meeting held November 13th, 1933 were read and approved as read.

~~Tentative budget to be adopted for the fiscal year beginning April 1st, 1934 was submitted for the purpose of making tax levy on the 1933 valuation for tax purposes. Thereupon, Trustee Rockwell moved and Trustee Hall seconded the motion that the tentative budget as presented be approved and that levy be made on tax valuations for the year 1933 to meet this budget. Upon roll call said motion was carried by the following vote: Yea, Trustees, Hall, Jelsema, Low, Preston, Rivers and Rockwell. Nay, none.~~

Trustee Low introduced an ordinance entitled "AN ORDINANCE IN RELATION TO TAXES FOR THE YEAR 1933". Said Ordinance being numbered 69, which the Clerk then read in full. Whereupon, Trustee Rivers moved and Trustee Jelsema seconded the motion that said ordinance be passed and adopted and be numbered 69 and published according to law. Upon roll call said motion was carried by the following vote: Yea, Trustees, Hall, Jelsema, Low, Preston, Rivers and Rockwell. Nay, none.

There being no further business to come before the meeting it was regularly moved, seconded and carried that meeting adjourn.
